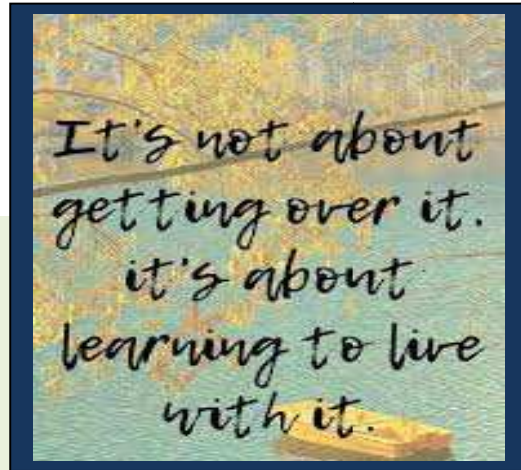
**I'm unreliable. I'm late. I'm disorganized.

family when I moved to Arizona. I knew how much was going to miss these precious people and so many others. And I do have to confess that I haven't been



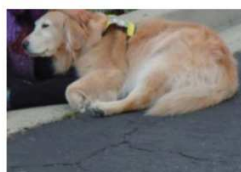
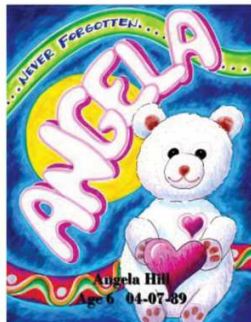

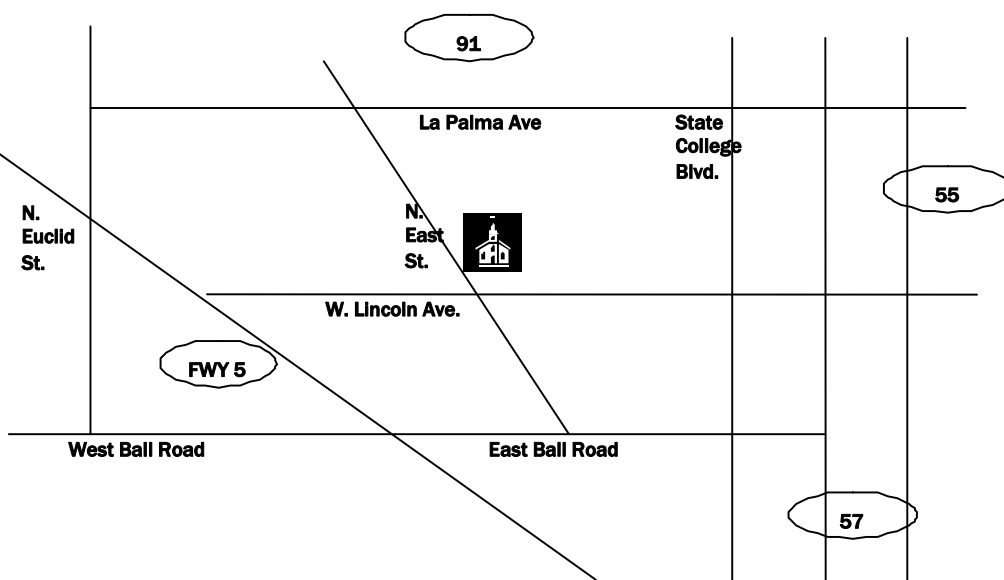
