# My Son's Story Carl Dan Claes

Carl Dan Claes was born on the first day of spring and it was the happiest day of my life. On May 16, 1995 Carl was marched down a lonely, dark, rocky trail and executed by a monster and his cohort. After shooting Carl at point blank in the back of the head they returned and shot Carl 2 more times in the back of the head. The two then went and ate fast food. My endless nightmare and heartache began. There is no escaping it, only trying to function. The jury convicted in 3 hours first degree murder and the Special Circumstance for Financial Gain as his killer had absconded with Carl's DJ system purchased to help Carl heal from the death of his grandmother in late March 1995. Bought for Carl's creativity and to earn money. The monster was on probation and had a violent past. Has tried to kill an inmate while in prison and now an Aryan Brotherhood shot caller. The shooter was a juvenile tried as an adult receiving Life Without Parole plus ten years sentence upheld by all appeals. Since I have had to endure a resentencing in 2015 where the sentence was changed to 35 years to Life. In 2019 I had a Board of Parole Hearing. There are endless hearings thanks to the Legislature hell bent on letting every psychopath out on the streets again. Most recent to drop the gun enhancement not dropped but impossible to track all these hearings to let the most violent of violent out of prison based on "the juvenile brain" and total disregard to the science of the psychopath brain, politically correct known as "anti-social personality disorder." I miss my boy every hour of the day and night. I am so sorry and sad for all of us members of Parents of Murdered Children. As they say, "a grief like no other." I miss Carl's laughter, our talks, and Carl's kindness. Thank you for never forgetting Carl.







# **Coping By Nancy Aguliar**

Cope..how does one cope after their child is murdered?

I have found, myself, moreso as surviving. Each day was a solo journey, when Jesse was murdered. It was chaotic, and horrific. The horrific continues day by day, turning into year by year..that is coping. Learning to live with the gut-wrenching, painful emptiness, because I must. A piece of myself was ripped out of my chest, from my heart, and it was tortured and murdered by fire!

I was alone, very little family support. Thankfully my POMC family was here, for many years, I don't know how I would have made it? God gave me the courage and strength to survive, and cope with each day. Cope is a struggle. I cannot quit. Even with Earthly Justice, it isn't enough...the murder continues to haunt, to torture my mind. How does one COPE, knowing your son's life was stolen, from another human being's choice? It is my life sentence. I guess I am learning to cope with this reality? Kind of like wandering in the desert, searching, alone...endless sand dunes, heat, and exhaustion.

Wow Christina, to cope, is a truly hard question to answer.


